**ORDER NO. 186 OF 2013**

The president is pleased to appoint the following officers of **India Revenue Service (Income Tax)** to the grade of **Joint Commissioner of Income Tax** purely on **Ad-hoc** basis in the **PB-3 Rs. 15,600-39,100+7,600/-** with immediate effect and until further orders.

2. The promotions are intended to be purely of **Ad-hoc** nature and subject to the following conditions:

- (i) Such appointment shall not confer any right to the officers for continued officiation or seniority or for regular promotion and shall be governed by the instructions of DOP&T as contained in O.M. dated 30.3.1988 and instruction issued by Government from time to time,
- (ii) Outcome to the judgement of the Hon'ble Supreme Court in SLP (C) No. 21339/2012, and
- (iii) Will not confer any right or equity in favour of the appointees.
- (iv) It is clarified that the officers are retained in the same Region only till next AGT. They will be considered for transfer out of the Region on promotion as per the Transfer guidelines definitely at AGT-2014 in April / May, 2014.
